In addition, Federal Financial Participation will not be available to the State for any Medicaid residents admitted to the facility on or after June 10, 2023. For Medicaid residents admitted prior to that date, Federal Financial Participation may continue to be made to the State for up to 30 days of covered services to qualified residents furnished on or after June 20, 2023, the date of termination.
